A meeting of the selection committee was held on August 21, 2025, to review and qualify the bid packages which were submitted. The selection committee present consisted of members Kyle Fruth, Dan Hartley, Kristina Johnson, and Ted Tryka. Supervisor Nick Casalanguida and District Manager Russ Weyer were also present. District Council Alyssa Willson attended virtually via Microsoft Teams.

The following two (2) companies responded:

Capling Leveling, Inc. South FL Excavation, Inc.

The bid packages were reviewed independently by each committee prior to the meeting. During the meeting, the committee reviewed each bid for Preliminary Requirements and Financial Capacity which received a Pass/Fail grade. Both bid packages were deemed responsive by the committee with a passing grade. The committee then discussed both bid proposals based upon the three scoring categories – Experience, Personnel & Equipment, Price, and Schedule. After discussion, the committee arrived at a consensus scoring for each company and category. The results, with bid prices, are as follows:

1) South FL Excavation, Inc. 100 Points \$ 2,050,130.90 2) Capling Leveling, Inc. 94 Points \$ 2,523,713.04

The bid scoring results sheet is attached for reference. (Note – all the bids were checked for mathematical errors, and none were found).

The selection committee recommends that the Board of Supervisors accept the rankings as presented and begin contract negotiations with the highest ranked company, South FL Excavation, Inc.

WHEREAS, the Brightshore Community Development District (the "District"), a local unit of special-purpose government created and existing pursuant to Chapter 190, Florida Statutes, and located in Collier County, Florida, has competitively solicited proposals from contractors interested in providing services for the District regarding its Immokalee Road Roundabout construction project (the "Services"); and

WHEREAS, the District has received and evaluated proposals from four (4) contractors interested in providing the Services; and

WHEREAS, after review and consideration of the proposals received by the District, the Board hereby determines to award 100 points to South Florida Excavation, Inc. and 94 points to Capling Leveling, Inc. based upon the evaluation criteria found in the RFP; and

WHEREAS, the Board hereby determines its intent to award the bid to and subsequently enter into a contract for Services with South Florida Excavation, Inc. as the most responsive, responsible proposer in accordance with the terms of the RFP.
